Ad 5) Discussion: Internationalisation report and annual report from the Student Counsellors

The Study Board discussed three of the annual reports on which the Program Report 2022 will be based: The internationalization report, Follow up on the Study Environment Survey 2021 and the annual report for the supervision (in Danish).

Regarding the report of internationalization, the board noted that the number of international students is decreasing. The matter of the maximum of non-EU citizens was noted.

It was mentioned that this is again a matter of recruitment and public outreach (presence).

The Board clarified that the Erasmus-agreement has not been in use the last years.

Regarding the report from the student counsellor, the figures mentioned as participants in events during the year, may need to be revised.

Regarding the follow up of the Study Environment Report the Board noted that the student perspective will be included at future teacher seminars.

The use of Study Groups was discussed, including the matter of including the benefits of collaboration in the exam (group exams). The implications for a heterogeneous student population were discussed and it was mentioned that TEACH has the means to facilitate the process.

It was mentioned that the final report should clarify whether it was a general issue, a CAS-issue a matter mainly regarding theology-students.
