## Agenda

#### **Constitution of the new Study Board** Ad 1)

The Study Board elected Karen Lauterbach as the new Chair of the Study Board and Kijoli Sofie Funder Yurary will continue as Vice Chair.

# Ad 3) Approval of the agenda

The agenda was approved.

# Ad 4) Approval of the minutes from the last SB Meeting

The minutes from 25 November were approved.

Follow up on item 10: the action plan, which the Study Board has approved of, includes a tutor in the budget in addition to the student counsellor.

On the agenda for the next meeting (cf. the minutes): Course evaluation and Semester Start Survey.

# Ad 5) Urgent applications processed since last meeting

a) One application for dispensation for registration for the MA thesis before having passed 90 ECTS. The Study Board approved the application with the provision that the student register for the last exam in the re-exam period.

b) One application for dispensation to take the re-exam in Economic Development in Africa as the ordinary exam. The Study Board approved the application due to the special circumstances.

c) One application for dispensation to upgrade an optional course from 7.5 to 15 ECTS. The Study Board did not approve the application since the optional course was only offered as a 7.5 ECTS course.

The Study Board discussion the issues about the optional courses.

# Ad 6) Applications for dispensation, credit transfer and professional master study plan/final project

a) One application for dispensation to postpone the oral thesis exam with two and a half month. The Study Board did not approve the application, however, granted the student with a dispensation to take the thesis exam as a long distance exam via Skype.

b) Three applications for dispensation to take the thesis exam as a long distance exam. The Study Board approved the application due to the special circumstances.

c) One application for dispensation for extension of the thesis deadline. The Study Board approved the application due to the special circumstances (medical certificate). PAGE 2 OF 6

d) One application for final credit transfer of three courses (22.5 ECTS), *Development Theory & Practice, Society and Natural Resources, Afrikaans Intensive A*, taken at the University of Cape Town. The Study Board approved the application and the three courses will replace optional courses for 22.5 ECTS.

The Study Board discussed the criteria for when dispensations may be granted for Skype exam. The Study Board will follow up on this on a coming meeting.

# Ad 7) Corrigendum to the study guidelines for the Professional Master programme

MBJ informed the Study Board about the changes. The Head of Studies will approve the study plan from now on. The Study Board approved the corrigendum.

# Ad 8) Exam forms

CSJ informed the Study Board about the work of reducing the exam forms at UCPH.

A paper of persisting forms and of suggested exam forms at CAS was handed out.

The Study Board discussed the suggestion of exam forms and the Chair will bring the suggestions to the department (CAS). Subsequently, the Study Board must approve of the exam forms. It is important to take the revision of the study curriculum into consideration.

KL drew attention to the fact that the approval of the syllabi is time consuming for the teachers.

### Nature, Population and Society in Africa exam

Seven-day take-home exam is a suggestion for other courses. The students pointed to the importance of feedback for this exam. It is a possibility to have shorter exam paper and then use the extra time to give feedback.

### **Economic Development in Africa exam**

The course may be reduced to a 7.5 ECTS course following the revision of the study curriculum. The students were not in favour of reducing the exam to be solely an oral exam. A portfolio exam could be a possibility. PAGE 3 OF 6

#### Religion, Culture and Society in Africa exam

The course may be reduced to a 7.5 ECTS course following the revision of the study curriculum. An internal censor from outside CAS (AKH) would not be a problem for the exam.

### Politics, Development and Change in Africa exam

The current exam form is very time consuming. The suggestion is to let the students chose between participation (precondition) or to write an extended exam paper.

### Kiswahili exam:

If possible, the external examiner for Kiswahili II must be found in Denmark.

# **MA-thesis exam**

CSJ informed about the possible thesis exam forms. If the thesis exam must remain a written-oral exam, the oral exam must be planned in a fixed week.

The Study Board noted that it could be a problem if the oral thesis exam is planned at the same time as the other exams.

# Ad 9) Discussion on the requirements for being accepted into the CAS-program

Theology bachelors are not per se admitted to the master in African Studies. However, there is a need for the theology students at the faculty to know that they can apply for the MA Programme. It is a tradition to admit theology students from UCPH.

# Ad 10) Approval of the Head of Studies' course evaluation report (spring 2016)

There is a problem about students' attendance in the evaluations. The Study Board suggests integrating the evaluation of courses with the exam submission.

The report was approved by the Study Board.

# Ad 11) The competence profile
