3) Applications for dispensation and credit transfer

- a) One application for exemption from the rule to take the MA thesis exam as the final part of the MA programme (Study curriculum 4.3) was approved since the student will only be missing 15 ECTS and have already attended the course.
- **b)** One application for dispensation to register for 15 ECTS PDC exam in the spring semester was approved, as the course is figuring in the study plan of the professional master student. The teaching is equivalent with the 7.5 ECTS, since the course is not offered for 15 ECTS.
- c) One application for dispensation from a professional master student to take the final project exam as a long distance exam was approved because of the special circumstances.
