Ad 1)	Approval of the agenda The study board approved the agenda.
Ad 2)	Approval of the minutes from the previous study board meeting The study board approved the minutes.

Ad 3) Urgent applications processed since last meeting

- a. The study board decided not to approve an application of credit transfer from MSc Program in Accounting and Financial Management from Stockholm School of Economics since the courses were not close related to African Studies.
- b. The study board approved an application of credit transfer to the professional master programme. The course "Nature,

Population and Society in Africa" (15 ECTS) will be included in the education. The courses "Modern Conflict, Was and Mass Violence in Africa" (10 ECTS) and "Helping Africa?" (10 ECTS) will be credit transferred to *Thematic course* (15 ECTS).

- c. The study board decided to approve an application for preapproval of credit transfer. The course "Introduction to Anthropology" (15 ECTS) from Department of Anthropology, University of Copenhagen, can be credit transferred to *Thematic course* (15 ECTS).
- d. The study board decided to approve an application for dispensation to reduce the study activity requirement in spring 2019 due to special circumstances.
- e. The study board decided to approve an application for dispensation to postpone the thesis deadline due to special circumstances.
- f. The study board decided to approve an application for dispensation to register for the thesis after the registration deadline due to study progression.

Ad 4) Applications for dispensation and credit transfer

a. The study board decided to approve an application for dispensation to register for the *Project-based module* (*Internship*) without having followed the course *Advanced Research Methods* and having submitted the proposal for the Internship. Furthermore, the study board granted the student with an exemption from the rule that the compulsory courses and elective components must be taken in the established order.

Ad 5) Discussion: Feedback to students

The faculty must implement feedback for students in the teaching from 2020. It is therefore important to mark the type of feedback for each course on the course descriptions. This information must be ready in February 2020.

Ad 6) Discussion: Implementation of the new thesis model The thesis start dates, the submission deadlines and the assessment deadlines are all fixed and are common dates at UCPH.

The two study boards at the faculty must agree on registration deadlines – when must the students complete the thesis contract?

The Study Board of Theology has suggested the dates January 2nd for the spring semester and June 1st for the autumn semester.

The Study Board at the Centre of African Studies suggests December 1st and agrees on June 1st.

The study board emphasises that with the suggested date 1st December, the students are able to get in contact with their supervisor right up to the registration deadline, which is not the case with the date 2nd January. In addition, the 1st December is the deadline for registering for regular courses in the spring semester and it matches the registration deadline for the thesis in the autumn semester.

The Study Board of Theology will discuss the suggested date for thesis registration for the spring semester at their next meeting.

The thesis length will be reduced to 100,000-150,000, and the list of literature will be reduced to 1,800-2,800. The assessment criteria should be the same, however, the expectation from the examiner and external examiner should be reduced.

Ad 7) Information and discussion: UMV results (AMF)

The director of studies went through the action plans. The action plans are a proposal for both study boards. Nothing new has come up after going through the free-text responses.

The study board had the following comments to the action plans:

- Notes to action plan number 1: There is a desire for more seating places at the "CAS vandhul" and a dining table (instead of a sofa group) with chairs all around.
- <u>Notes to action plan number 3:</u> Regarding reading places there may be issues about to which buildings and hallways the student ID cards work.
- <u>Notes to action plan number 10:</u> Communication channels must be clearly communicated to the students at the start of the study (previous year's action plan).

Ad 8) Discussion: Selection criteria

The teacher group has discussed whether work experience should not be a part of the selection criteria. They agreed that it should not be selection criteria. Therefore, the study board decided to keep the selection criteria as they are. PAGE 3 OF 4
