5. Discussion: Course evaluation, Spring 2022

The Study Board discussed results of the teaching evaluation spring 2022 and proposes actions and recommendations for the Head of Studies.

That staff at CAS had already discussed the teaching evaluation. The Head of Studies applauded the variety of teaching at CAS and the positive feedback from the students. One issue was the thesis supervision (thesis seminar). The Board discussed the need for a revision of the format.

The board noted that the numbers of replies go up if the evaluation is done in class. Numbers from thesis students – which reply individually – could be higher.

In general, it was noted that CAS has a high number of replies for the regular courses. And, equally important, with very positive feedback from the students.

The feedback from the courses is extraordinarily good this year. The number of respondents is generally high – apart from some courses where digitalization might help.

Evaluation of thesis supervision has a low number of respondents, but the once that replied were very positive.

It was discussed if the evaluation of the thesis should be answered before the oral defence. The Board hopes that the work on a digitalization might help in this regard.

The Study Board discussed the proposition of a thesis seminar before the thesis contract. Students could meet lecturers and be introduced to examples of problem formulations. The seminar could also inform of the registration module and the administrative framework and rules surrounding the thesis.

The Board found that the current set-up of the thesis seminar works very well, however is mostly helpful for (and attended by) student who are in the country at the time of the seminars.

It was suggested to have a single online seminar in November that introduces the students to the general requirements of the thesis.

The Board proposed:

- a continuation of the first thesis proposal in "Advanced research methods".
- the introduction of a preliminary thesis introduction.
- a change of the current thesis seminar.

The Chair will bring the issues to the CAS teachers' group.
