3. Discussion: Matters arisen from approval of minutes (sec.)

The Study Board discussed status of items decided on last meeting. No further remarks.

4. Approval: Applications to the Study Board (sec.)

5. Orientation: Course evaluation report (in Danish) from the previous academic year (by the Head of Studies)

The Study Board discussed the Head of Studies' "Report on completed teaching evaluations 2023", which reports the overall conclusions from the faculty regarding evaluations of teaching in autumn 2022 and spring 2023.

At CAS the evaluation is a product of the different background of a very international student body.

The courses should be mandatory graded in categories A, B or C (not public). There have been no issues at CAS.

The issue with some teachers not handing in the evaluation results was discussed, in relations to improving the number of respondents. Both items, results and responded, may change with the digital evaluation. The Board was generally very positive towards the report.

7. Orientation: Inspiration catalogue on learning communities

At CAS it was noted that the lecturers already are very available, with feedback that suggest very engaging teaching.

In this programme some students may have issues with being new to Denmark and UCPH, however the students report that the current class has settled good but there are concerns regarding one foreign student. The Board discussed how to inform our students of relevant seminars on other faculties at UCPH and build connections to students from other programmes and faculties.

8. Initial discussion: Changes to curriculum

The Board did not find pressing matters and decided not to start the revision process this year.

UFM has ordered UCPH to adjust the admission requirements and selection criteria for master's degree programmes. In this connection, US has submitted a review of TEO's programmes. The Study Board discussed relevant sections of the review and set up a fast-working committee (Stig, George, Karen and Stephan) for further work (deadline 1 March 2024).
