# Ad 5) Discussion: Review of Program Statement 2023 - Follow-up plan

The Board reviewed the progress of the Follow-up Plan for the Program Statement 2023 and concluded that the issue of study progression is making good progress.

# Ad 9) Discussion: Internationalization report and annual report from the Student Counsellors

The study board discussed the annual reports on internationalisation and student counselling.

The internationalisation report regards the whole faculty (all programs). For African Studies outgoing students are 2/3 of the students is attending Field Studies.

Full Degree Students are on decline – however is historical fluctuant.

The Annual Report from the student counsellor reported that the last year the faculty has kept up the number of events — which is satisfactory for a faculty our size.

Open House events has had a good attendance, with a well working format.
